Jerry Skees has a unique career that blends experience in academia, government, and the private sector. His research and work focus on public policy for natural disaster risk in agriculture. Dr. Skees is a leading innovator of agricultural insurance programs, developing new markets for sharing catastrophic risk in the United States and globally. In 1989, on leave from the University of Kentucky, he served as research director for the Special Commission on the Improvement of the Federal Crop Insurance Program and then as a visiting scholar at the Economic Research Service of USDA. Since 1997, he has worked in over ten emerging or developing economies, and with ongoing work in: Mongolia, developing and pilot testing a new livestock insurance about to become a nationwide program, which won the 2006 World Bank Golden Plough Award for innovation; Peru, designing a new ENSO Insurance product that offers early payment for catastrophic losses from El Niño; and Vietnam, developing two products using index insurance to protect rural lenders in the Mekong Delta from flood and coffee producers in the Central Highlands from drought.

Skees has published over one hundred research articles and is co-author of the award-winning book, Sacred Cows and Hot Potatoes: Agrarian Myths in Agricultural Policy. While at the University of Kentucky, he has won several outstanding teaching awards and the Thomas Poe Cooper Research Award.
